Rules governing the use of facilities:

1. Parking is limited to designated areas, or by direction of the ranger.
2. Rosters containing the names of all campers, adult leaders, guests, and names and telephone numbers of persons to be contacted in the event of an emergency, must be submitted to the ranger upon entry to the Island.
3. Groups bringing canoes, boats, or other special apparatus, must register such items with the ranger.
4. All campsites, or day camp areas, are considered private and may not be entered at any time without invitation and escort by a member of the assigned group.
5. Fires must not be left unattended at any time. An area must be properly prepared before a fire may be built.
6. Fires must not be within, or immediately adjacent to, any structure unless contained within an approved fire housing device. The ranger must approve the validity of a fire housing device before it can be used.
7. The use of liquid fuels will be based upon the standard policies and procedures of the user groups. If liquid fuel is used, it must be by, or under the direct supervision of an adult leader.
8. Inhabited outbuildings must have an up-to-date fire extinguisher and working smoke detector / alarm. If necessary a fire extinguisher and smoke alarm can be checked out from the ranger.
9. Use designated latrines only. Temporary latrines may not be built in or adjacent to campsites.
10. Personal cleanup, or the washing of dishes, utensils, cooking equipment or clothes, must be limited to the campsites or other designated areas. No washing at or around drinking water supplies.
11. Radios, tape players of musical instruments must be kept at a low audible level at all times so as not to be offensive to other groups.
12. Sites must be kept and/or left in a neat and clean condition at all times.
13. Trash must be removed from the Island by user groups. Trash bags are available for this purpose from the ranger for a nominal fee.
14. Axes, hatchets, saws, grass whips and other similar implements, are considered hazardous and may only be used under the direct supervision of an adult leader.
15. 10:00 PM is designated as the time for lights out or a significant reduction in noisy activity.
16. Canal water is not safe for drinking, and may be used for fire buckets only.
17. The following activities, or items, are strictly prohibited.
 - a. Swimming
 - b. Alcoholic Beverages
 - c. Illegal drugs.
 - d. Firearms
 - e. Fireworks
 - f. Chain saws (without permission)
 - g. Snowmobiles
 - h. Unlicensed / unauthorized motor vehicles
 - i. Cutting of any standing growth (without permission)
